Shown here on Senior Shirt Day – wearing shirts that proclaim their college choices – the 76 members of TMI Episcopal’s **Class of 2018** are continuing their education at Baylor, Rise, SMU, Texas A&M and UT-Austin; Brandeis, Georgetown, Georgia Tech, Harvard, MIT, NYU, Northeastern, Penn State, Sewanee, UCLA, the U.S. Air Force Academy, University of Pennsylvania, Vassar; Regent’s University (London), the University of St. Andrews and many others. Three alumni were accepted to special programs for independent study and multidisciplinary majors, and two are taking gap years for internships, volunteer work and study abroad.

His paper, “From Alamo Heights to Even Greater Heights,” traced the reasons for TMI’s move to the present Alkek Campus in northwest San Antonio, was written for a TMI course in military history taught by **Kristian Marks**, a retired Army colonel who previously taught at West Point and Ohio State.



Multisport athlete **Ana Ross '18** won a 2017 TAPPS state cross-country championship medal and was named Cross-Country Athlete of the Year by the San Antonio Express-News. She also won a 2018 regional championship in track and field and was a state finalist in the 1600m and 3200m events. Ana is now a first-year student at UT-Austin, where she pursues an interdisciplinary arts and science major in the Plan II Honors Program.

## WAYS TO GIVE

### THE TMI FUND/ UNRESTRICTED GIFTS

Gifts made to the TMI Fund are not restricted to any particular program or project and are used in the area of greatest need.

### IN HONOR & MEMORIAL GIFTS

Honor someone special for a birthday, graduation, anniversary or other milestone. Memorial gifts recognize someone who has passed away.

### ENDOWMENT

A permanent investment account that serves as a source of income that supports the school's ongoing needs and future of TMI.

### SPECIAL EVENTS

Proceeds from the Stars Over TMI and Tee Off Fore TMI support the operating budget of the school.

### RESTRICTED GIFTS

Designated for specific purposes, such as scholarships or campus improvements.

### BEQUESTS & PLANNED GIVING

Since each individual's financial and tax planning circumstances can vary, donors are encouraged to seek counsel of their tax advisor to explore many options of giving that allow the donor to maintain current income levels, while planning a long-term gift to the school.

### RECURRING GIFTS

The TMI Recurring Gift Program enables donors to build a significant annual contribution through installments.

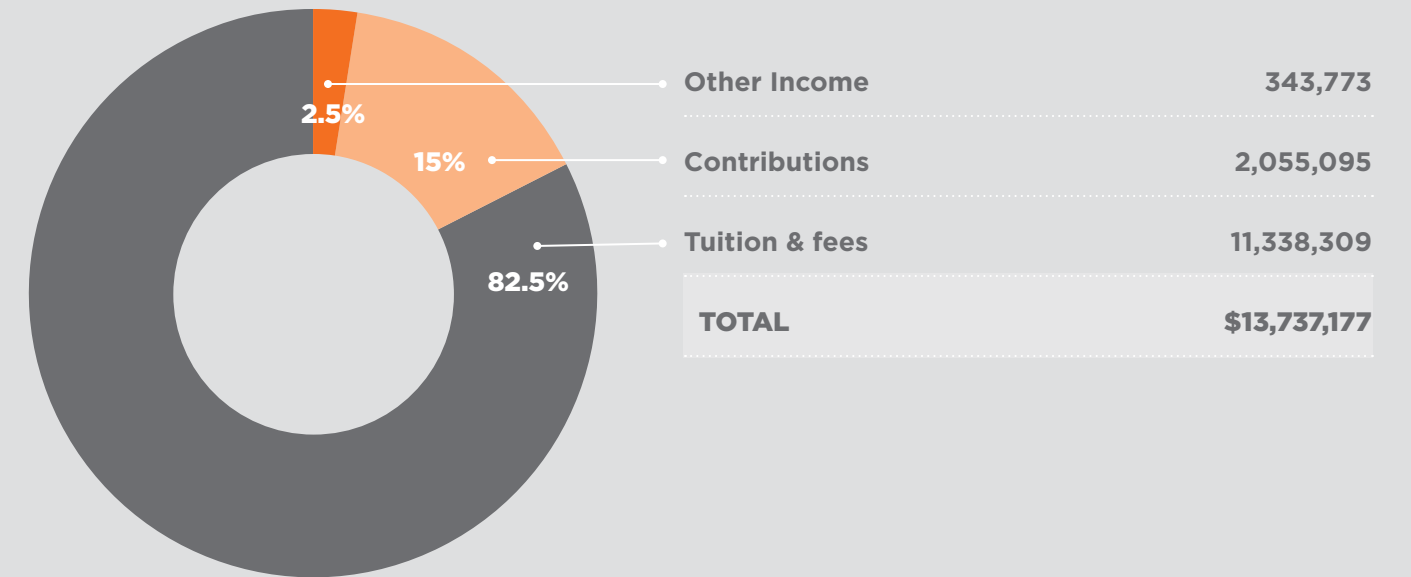

# WHAT IS ANNUAL GIVING?

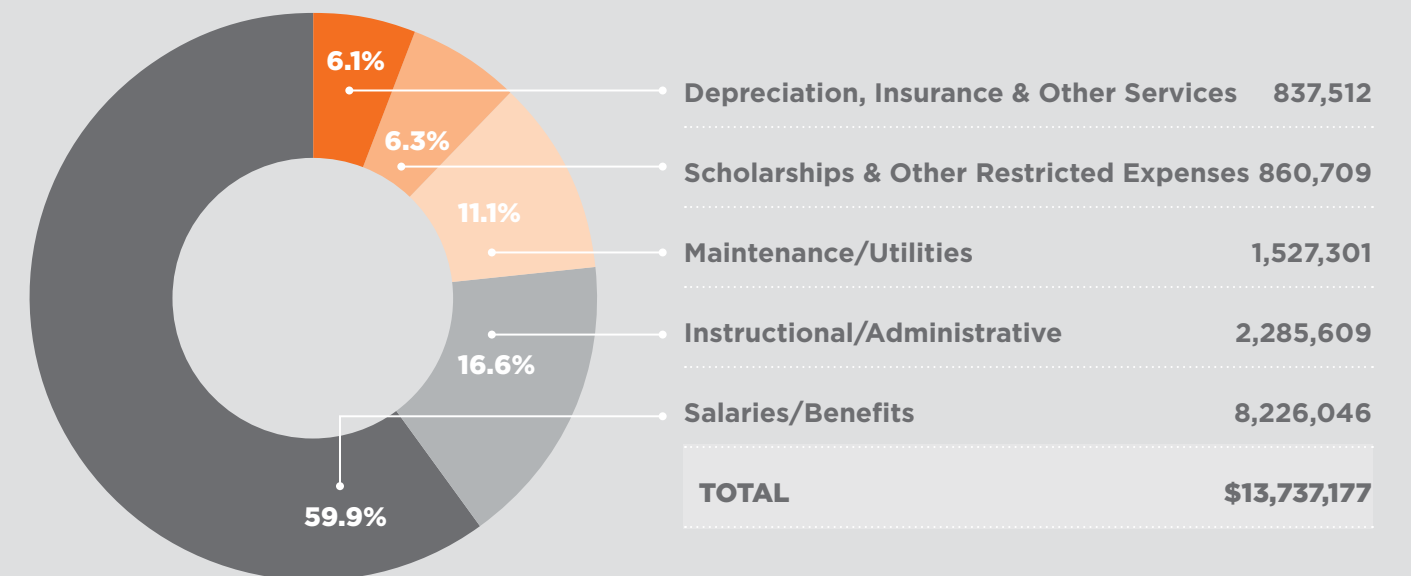
TMI's annual giving programs support the yearly operating budget for the school and ensure that every student has the opportunity to receive more than just an excellent education but an outstanding one at TMI.

The TMI Fund (formerly known as the Annual Fund) is the single most important philanthropic priority of TMI's annual giving programs. It makes up close to 75% of our total annual giving dollars every year. Gifts to the TMI Fund have a direct and tangible impact on every student, every day. During the 2017-2018 school year, Annual Giving was just under \$630k, and helped us increase investment in campus infrastructure, professional development for our faculty and staff, and enhancements to our programs, without running a cash flow deficit from school operations.

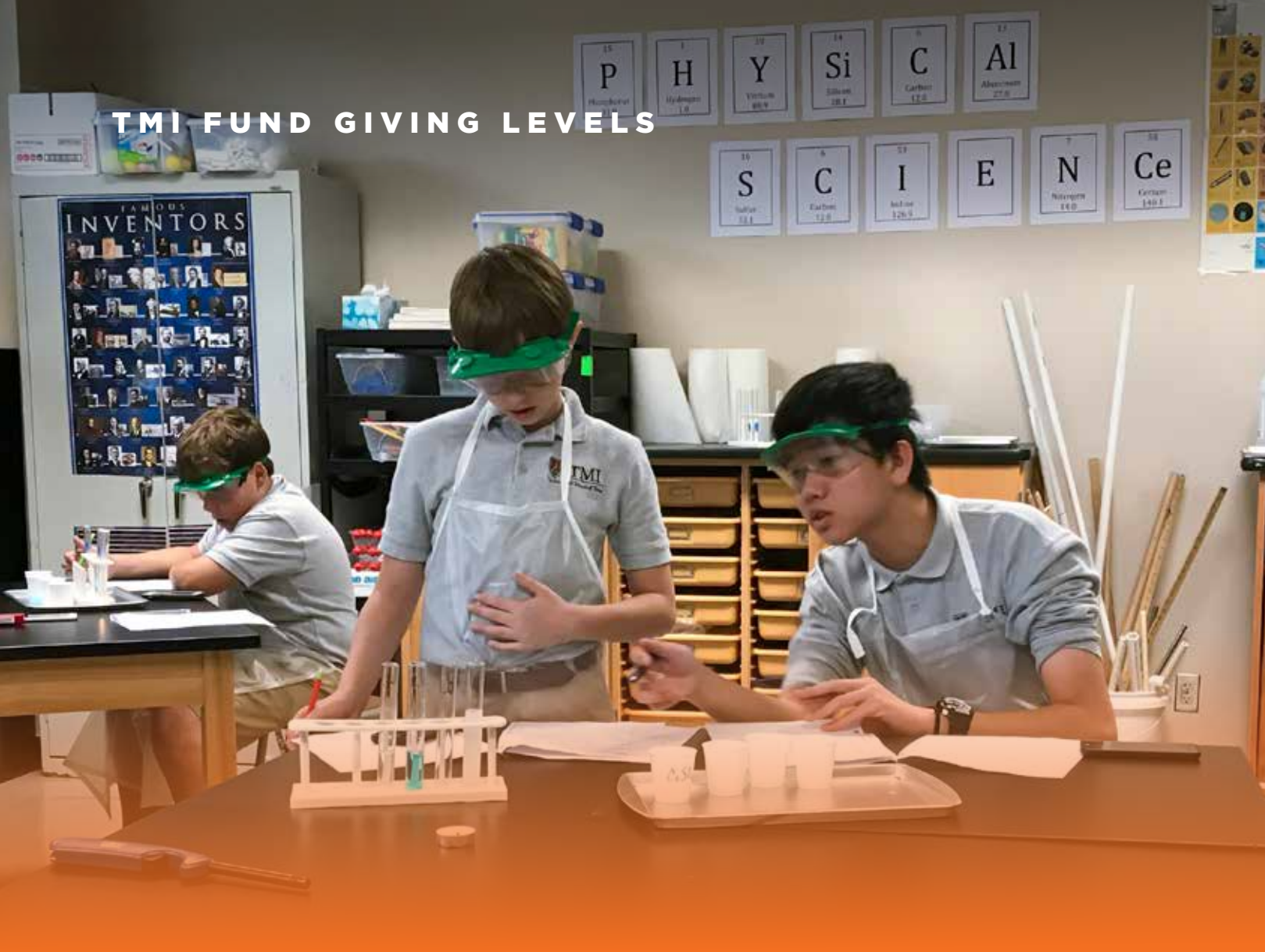
